3. “Push Past it Playbook” will be made available to all authors at a wholesale rate between \$7.00-8.00 per copy plus applicable tax and shipping. Authors have permission to resell "Push Past It Playbook" at a retail price of no less than \$10.00 and may market and offer "Push Past it Playbook" on their independent website, at vendor events, and personal appearances. A separate agreement must be made with Rhonda Culton regarding any commercial reseller/retailer or bookstore. Rhonda Culton retains the right to market and sell "Push Past It Playbook". Rhonda Culton will not offer royalties on copies she sells; neither shall authors be responsible to pay royalties to any other contributor to the anthology.
4. Copyright in the work shall be owned by Rhonda Culton who shall have the following rights under the copyright: The right to publish the work in print and electronic formats, and all related rights necessary or desirable for the full use and enjoyment of such right of Publication, including but not limited to the right to republish the work in whole or in part in future issues of "Push Past it Playbook." The right to publish, in print or electronic format, short selections from " Push Past it Playbook” for publicity and scholarly purposes, as deemed appropriate by Rhonda Culton, without payment to the Author(s). The “Push Past It Playbook,” and any logos and designs created for exclusive use for these projects are proprietary and may not be used in any manner without consent of Rhonda Culton.

That the submission contains no statement known to be false, is free of any libel or libelous innuendo, and is in no other way harmful.
